Principal Deputy Assistant Secretary Hild:

It has come to my attention that the Department of Health and Human Services (HHS) Office of Refugee Resettlement (ORR) is considering awarding an Indefinite Delivery, Indefinite Quantity contract to a private entity to construct and operate an Influx Care Facility (ICF) to house unaccompanied children at the Grand Casino Hotel in Tunica, Mississippi. I write to express my opposition to HHS awarding this contract to this entity given the feasibility concerns of constructing and operating an ICF in Tunica.

From my understanding, if HHS awards this contract to this entity, the facility would have a funded capacity of 2,000 beds to house unaccompanied children. The medical and human services in Tunica is insufficient to support such a large number of unaccompanied children. I am deeply concerned that there are no acute care hospitals or critical access hospitals in Tunica County, should emergency medical care be needed. Many of my constituents have also reached out to share their concerns about the public safety, medical, and economic strains that this would place on their communities. HHS would need to provide childcare, health care, security, psychiatrists, translators, transportation, and other services to support such a large influx of unaccompanied children in a rural area that lacks the necessary infrastructure and labor to support such an undertaking. I am also concerned with ORR's history of chronic mismanagement and lack of oversight over ICFs, as documented by a number of reports from the HHS Office of Inspector General.<sup>1</sup>

Thank you for your attention to this matter. I look forward to your prompt response and request that you keep me informed of this contracting process and any future ORR contracting proposals or grant solicitations affecting the state of Mississippi.
